Criminal Law Clinic

SYLLABUS

GENERAL BACKGROUND:

The Demand for Justice Criminal Law Clinic (the Clinic) will give you the opportunity to assist KBA advocates in their pro bono representation of poor criminal defendants. You will experience the application of academic theory to the actual practice of law by working on live criminal cases with professional advocates. You will be involved in client interviewing and counseling; preparing letters and legal documents; reviewing records; researching the law to provide support for various legal theories; assisting in the drafting and filing briefs, and otherwise helping clients solve legal problems. Students typically handle between 4 and 6 legal matters for individual clients, depending on the duration and complexity of each case. You will work individually and in collaboration with others in the class. Your cases will primary involve criminal matters of defendants who cannot afford an advocate and do not meet the criteria for ex-officio representation. Accordingly, some of your work will take place in the General Department of the Basic Prosecution in Pristina, and Police stations in Pristina.

In addition, you will be involved in some community outreach work and will be required to present high school students with information about your clinical work, and about a variety of legal issues related to justice sector (rights, access to justice, accountability mechanisms, and legal reform) within the Pristina area. The clinic experience will involve you in interdisciplinary conversations, and will expose you to unique ethical and practical issues related to the representation of poor defendants. You will have an opportunity to discuss the concept of community and what it means to be an advocate within and for communities. You will explore strategies for attaining systemic change, where change may be necessary to correct a problem or injustice affecting a community of people. You also will work on other fundamental advocating skills such as interviewing and counseling, developing case theories and plans, direct and cross examination, and other advocacy techniques.

Our goal is to provide each of you with a rich and varied practice experience. Through exposure to real cases and clients as well as a variety of types of advocating activities, we hope to assist you in strengthening and developing versatility in your advocating skills and to assist you in shaping your professional identities and career plans. You will have the opportunity to work under the supervision of KBA advocates, and network and build professional relationship with different justice sector actors.

SUPERVISION:

With respect to your individual client representation, you will meet individually and in a group with a KBA advocate on a regular basis. You will meet individually with your advocate supervisor at least once each week and as necessary to prepare for and debrief case and client activities. We will all meet jointly for the classroom sessions.







The classroom component of this course is intended to convey information you may need to represent your future clients as well as to provide an opportunity for you to discuss, compare, analyze, and reflect upon your clinical experiences. There is a theoretical component as well. Toward this end, our work in class will be based upon your actual cases. You will be expected to actively participate in each class, and attendance will be mandatory. Below is a summary of the classroom component of your clinical experience.

LOGISTICS

All classes are from 16:00 to 17:30 p.m. on Tuesdays. We will meet in the Demand for Justice Office on the first day of class and for most classroom sessions. Some representation activities (advice, counseling, and advocacy) will take place in KBA advocate offices and, as required, at court or prosecutor premises. Lectures will be delivered by guest speakers who are legal professionals (Prosecutors, Advocates, and Judges), CSO representatives, etc.

TIME COMMITMENT

Representing real clients is an intensive experience. Consequently, your work in the clinic should average 5-6 hours per week [including class, casework, meetings with your advocate, etc.]. At least 1.5 of these hours must take place in the Law Clinic in regularly scheduled lectures. You are expected, however, to devote as much time as you need to work on client's case and to thoroughly participate in class, even if in some instances this requires that you work more than 5-6 hours some weeks or have to go to court or complete work during holidays. Advanced planning and communication with colleagues, clients, and advocates about competing schedules is therefore critical. Our goal is to provide high quality legal services to those who cannot otherwise afford an advocate. Once we agree to take on a case, we bear full professional responsibility for that matter and must perform accordingly. Effective planning, time and case management, and communication with your advocate, the advocate's clients, and fellow colleagues will be critical to your performance.

EVALUATION

Attendance and participation in the class component is mandatory. In addition to preparing for and actively participating in class and completing all course assignments in a timely fashion, you will be expected to support the representation of clients zealously and competently, abiding at all times by the rules of professional responsibility.

A single lapse in professional responsibility or judgment (e.g., missing a deadline, failing to adequately prepare, violating a client confidence or other ethical obligation, etc.) may result in being expelled from the clinic. Failure to attend class, weekly supervision meetings with advocates, or complete assignments as assigned and/or otherwise arranged with your advocate may also result in being expelled.
